## Good News

The **Treaty on the Prohibition of Nuclear Weapons** (TPNW) entered into force on 22 January 2021 as the first instrument of international humanitarian law to mitigate the catastrophic humanitarian consequences of using and testing nuclear weapons. By January 22, a total of 86 countries had signed the treaty.

For those nations that are party to it, the treaty prohibits the development, testing, production, stockpiling, stationing, transfer, use and threat of use of nuclear weapons, as well as assistance and encouragement to the prohibited activities. For nuclear armed states joining the treaty, it provides for a time-bound framework for negotiations leading to the verified and irreversible elimination of its nuclear weapons program.

So far none of the nuclear armed states have joined the TPNW. Still, it has been broadly welcomed as a significant milestone in the long and global effort to achieve a world free from nuclear weapons.

**TC Energy Cancels Keystone XL Pipeline.** The Canadian company TC Energy says it is canceling construction of the 1,200-mile Keystone XL pipeline, which would have carried over 800,000 barrels of oil each day from Canada's tar sands region across fragile ecosystems in the United States. The announcement came after the Biden administration revoked a key permit for Keystone XL in January, and follows years of Indigenous-led resistance against the project.

Meanwhile, **protests continue against construction of the Enbridge Line 3 pipeline.** In Minnesota 179 people have been arrested and charged with trespassing after a mass civil disobedience action on June 7. Water protectors are camped out at the headwaters of the Mississippi River, and they need reinforcements all summer long.

**Reprieve for Alaska's Arctic National Wildlife Refuge.** The Biden administration is suspending oil and gas leases in Alaska's Arctic National Wildlife Refuge that were issued in the final weeks of the Trump administration. The Interior Department said the Trump leasing program wasn't properly reviewed for its environmental impacts. **However**, the move comes a week after the administration defended a massive oil and gas project in northern Alaska known as the "Willow Master Project." Environmental and Indigenous groups are suing the government in an attempt to stop the multibillion-dollar deal with Alaska's largest crude oil producer ConocoPhillips, which was approved last year by the Trump administration.

**Washington State's Most Populous County Bans Use of Facial Recognition Technology.** A groundbreaking proposal to ban government use of facial recognition software was passed on June 1 by the King County, WA, council by a unanimous vote of 9-0. "The use of facial recognition technology by government agencies poses distinct threats to our residents, including potential misidentification, bias, and the erosion of our civil liberties", said the legislation's prime sponsor, Councilmember Jeanne Kohl-Welles. King County, home to 2.3 million people in and around Seattle, becomes the first county and one of the largest jurisdictions in the United States to pass such a ban.

Melanie Stansbury has won the **Special Election for a NM House Seat.** In New Mexico, Democratic state Representative Melanie Stansbury defeated Republican state Senator Mark Moores in a special election to fill the seat left vacant by Interior Secretary Deb Haaland. Stansbury has backed progressive policies including Medicare for All and the Green New Deal.

In May, **The Massachusetts House of Representatives rejected** an amendment to the state budget bill which would have Massachusetts adopt the International Holocaust Remembrance Association (IHRA) definition of antisemitism, a definition that equates criticism of Israel with antisemitism.

With only two days to respond before the amendment was considered, Jewish Voice for Peace-Boston, Massachusetts Peace Action, the Alliance for Water Justice in Palestine, and the Unitarian-Universalists for Justice in the Middle East mobilized quickly. Over 400 people wrote to the Chair of the House Ways and Means Committee, and to their own state representative and senator. In the end, the amendment was removed by the Ways and Means committee, effectively killing it.

**Death penalty abolished in Virginia.** In March, Virginia became the 23rd state to abolish the death penalty and the first Southern state to repeal the death penalty since the US Supreme Court reinstated the punishment in 1976. The new law, set to go into effect in July, comes as a major shift for Virginia, which has put to death more people in its history than any other state.

# Meeting Notes

## June 19, 2020 Annual Meeting

For our annual meeting, on Zoom, we had a speaker from Japan, Professor Donna McInnes, who spoke about Self Compassion, how to care for our sanity as we continue to oppose war. We should forgive and care for ourselves and others and stay focused on what we can do.

We acknowledged the death of member Peter Cameron.

We reviewed the completed year, and elected new officers.

The board voted on line, June 24, to not endorse the petition by "Pivot for Peace" about Twitter censoring their account about China, but, without our help, the account was later reopened.

The board voted online to be listed in an alert regarding Israeli annexation.

. . . We did not meet in **July**.

## August 25, 2020

We decided against endorsing a death with dignity movement, because it was outside of our mission statement, and we don't all agree on the issues.

We voted to sign an apology to Japan for nuclear bombing, requested by Nonviolence International.

## September 22, 2020

We voted to dedicate our Thursday Raytheon vigil to the annual Keep Space for Peace vigil.

Phil recommended a video, about Raytheon arming the Saudis in Yemen,

We noted the Saturday, September 26 Mass Peace Action vigils, calling to eliminate nuclear weapons. We would have signs at the Andover Indivisible BLM demonstration that day.

### **October 27, 2020**

We decided to send emails to fund raise for Oxfam, instead of meeting for a Stone Soup Supper.

Barbara Haack and Phil Noyce informed the attendees about the recent historic milestone of Nuclear Weapons Ban Treaty entering into force after Honduras formally joined 49 other states in the Treaty on the Prohibition of Nuclear Weapons. **On January 22, 2021, the UN Treaty on the Prohibition of Nuclear Weapons will enter into force.** The US has not signed it, so we should advocate that we do sign.

Barbara Haack strongly recommended that MVPP should make it its focus issue.

### **November 24, 2020**

**International Day of Action on Yemen** will be held on January 25, 2021. MVPP will hold a vigil at Raytheon on that day at 7:00 am MVPP plans to sign the Joint Statement “World Says No to War on Yemen” and join the long list of organizations opposed to US (Saudi) war on Yemen.

The **Nuclear Weapons Ban Treaty** will become effective on January 22, 2021. Phil Noyce suggested that a banner about the Treaty be prepared and displayed at planned vigils at Raytheon

Masood informed the attendees about the 13<sup>th</sup> annual **Convention for Palestine in the US** organized by AMP (American Muslims for Palestine), the on-line convention to be held Nov. 27-29, 2020. The convention will focus on Palestinians and the others suffering oppression and will be addressed by congresswoman Betty McCollum, political commentator Phyllis Bennis and many other scholars.

. . . We did not meet in **December**. The Donations Committee met and treasurer Kathy Robinson sent donations.

### **January 26, 2021**

We did not feel optimistic about prospects of reduced military spending by the new administration. The struggle for reducing spending on weapons of mass destruction and increasing spending for needs of the people, such as healthcare, must continue.

We agreed to renew meeting with US Representatives Seth Moulton and Lori Trahan; and supporting Senators Elizabeth Warren & Ed Markey.

Kathie Robinson reported receipt of additional copies of Frances Crowe’s book. A few copies of the book are being circulated among, and enjoyed, by the members already.

### **February 23, 2021**



MVPP members in CD3 plan to approach Lori Trahan and urge her to sign on the “No First Nuclear Strike” bill introduced by Senator Ed Markey.

Allan Sifferlin informed the attendees that State Senator Pat Jehlen and Representative Nika Elugardo have filed bills in the state legislature calling for divestment of the Massachusetts Pension Plan from companies selling weapons to Saudi Arabia.

### **March 23, 2021**

Kathie Robinson reported about payment of ‘rent’ though we were not meeting in the building.

We heard reports from meetings with US Representatives Seth Moulton and Lori Trahan.

## **April 27, 2021**

As an addition to the agenda, Dee Halzack brought up the Petition to Demand Congress add checks and balances to our nuclear system and enact No First Use. It is being endorsed by a coalition of organizations. Brian offered to send the petition out to the board so we could vote to endorse it.

We discussed a follow-up to the meeting with Rep. Lori Trahan's Chief of Staff. MVPP will send a thank you letter and we will call again within six months.

We voted to support the seven peace and justice bills filed in MA State Legislature in January and February 2021. MAPA and the Massachusetts Peace and Justice Network have partnered with progressive legislators to develop those bills. They address a range of issues, including nuclear weapons, the war in Yemen, Pentagon spending vs. a Moral Budget, divestment from weapons manufacturers, corruption, and lack of transparency.

Boryana reported on the Mass Peace Action (MAPA) annual meeting on April 24.

Phil Noyce read all the new signs that he is making and planning to make for the weekly Raytheon vigil.

## **May 25, 2021**

Dee will ask members of Lowell's 350 group to speak about their activities concerning climate change at our annual meeting.

The nominating Committee will prepare to update our officers list for the annual meeting.

We approved sending \$200, plus individual's gifts, to help in Gaza, through the Catholic Medical Mission Board

On Friday, January 22, 2021 MVPP members held a vigil at Raytheon to celebrate the historic milestone of Nuclear Weapons Ban Treaty entering into force. The vigil was joined by John Schuchardt and others from *The House of Peace*.

On Monday, January 25, 2021 MVPP members participated in *International Day of Action on Yemen* against the war on Yemen by holding a vigil at Raytheon.

Boryana Tacconi attended the Massachusetts Peace Action conference on January 23, 2021. This Conference pointed out that even though the Coronavirus has devastated the economy, it has not had any braking effect on the presidential and congressional push for spending more of our tax dollars on military and nuclear weapons development programs. The conference was focused on finding ways to continue to collaborate and cooperate in the development of a social movement strong enough to reverse the new nuclear arms race

## March 2021

Barbara Haack and Masood Sheikh met with Seth Moulton's new senior foreign policy advisor Schuyler Moore on March 8, 2021. Sunny Robinson, who had arranged the meeting through MAPA, did express the group's concerns about peace, justice, and military budget. but response from Ms. Moore indicated that Moulton's only focus was 'National Security.'

We met with Congresswoman Lori Trahan's staffer Mark McDevitt. Dee Halzak set up the meeting. Well prepared briefs were presented by Kathy Robinson (Our Ideals), Allan Sifferlen (HR 669, Restricting First Use of Nuclear

Weapons Act of 2021), Phil Noyce (A military veteran's view), and Dee Halzak (Money better spent on Public Health). Mr. McDevitt shared that Congresswoman Trahan's plans very much align with ours. He also stated that Ms. Trahan was also working on restoring authority to declare war back to Congress.

We held our weekly vigil at Raytheon with a St. Patrick's Day theme, including a frozen bagpiper.

Some of us joined demonstrations supporting Asians, after the murders in Atlanta, GA.

## April 2021

MVPP members participated at the annual Vigil to Abolish the Death Penalty, held in Reading on Good Friday.

## May 2021

Mary Kate organized a zoom meeting with Arthur Brien, now at his daughter's house. We were happy to see each other.


