## GOOD NEWS

**Kinder Morgan Abandons New England Pipeline Project.** In April, the energy giant Kinder Morgan Inc. retired its controversial proposal for a natural gas pipeline going through parts of Massachusetts and Southern New Hampshire. Kinder Morgan said that its Northeast Energy Direct project didn't receive the commitments from big customers that it needed to proceed with the \$3.3 billion plan, which would involve building a 188-mile pipeline from a point west of Albany, NY, to Dracut, MA.

The Boston Globe wrote on April 20, *“The company’s withdrawal represents a huge victory for its array of opponents, ranging from grass-roots organizations to established environmental groups to powerful politicians. They also included residents of the many towns that would be affected by pipeline construction and activists who worried it could make New England overly dependent on natural gas.”*

Several of us in MVPP were active in opposing the pipeline, so we can take a moment to accept the Globe’s pat on the back and celebrate, and then join our neighbors in their ongoing fight to stop the West Roxbury Lateral pipeline which is being built by Spectra Energy right through densely populated West Roxbury residential neighborhoods.

**Verizon Workers Claim Major Victory.** On May 27, Verizon workers celebrated a huge victory when the six-and-a-half-week strike came to an end with a tentative contract agreement. Under its terms, Verizon agreed that no additional jobs will be outsourced overseas, while increasing the number of calls routed to domestic call centers. This will result in the creation of 1,300 new call center jobs along the East Coast, first-ever contracts for Verizon wireless store employees in Brooklyn and Everett, Massachusetts, and raises of nearly 11 percent over the life of the contract.

The workers beat back demands from the company to cut pensions, transfer workers out of state for up to two months, and cuts in disability and accident benefits.

Nearly 40,000 workers had been on strike since mid-April to the first week of June. This time they have much more to celebrate in comparison to the big strike in August 2011 when about 45,000 Verizon landline technicians and customer service employees returned to work without a new contract and losing two week’s pay.

The two unions representing the Verizon workers – Communications Workers of America (CWA) and International Brotherhood of Electrical Workers (IBEW) – hailed the contract agreement as a victory for the workers and the unions, and in a broader sense, for the American middle class.

**Massachusetts Teens Win in Landmark Climate Change Lawsuit.** Four teenagers who sued the Commonwealth of Massachusetts over its failure to adequately address the threat of climate change won a major court case on May 17, adding to a string of victories for young activists. The Massachusetts Supreme Court ruled in favor of the young plaintiffs, agreeing that the state Department of Environmental Protection was not making good on its goals for reducing greenhouse gas emissions 25% below 1990 levels by 2020, as requested by a state law passed in 2008. The court ordered DEP to produce and implement stronger and more expansive regulations leading to mass-based reductions in greenhouse gases.

The teenagers – two Wellesley High School and two Boston Latin School students – had the support of the Conservation Law Foundation and the Massachusetts Energy Consumer Alliance.

This case is one of several similar cases in federal district courts in Oregon and Washington, and in the state courts of North Carolina, New Mexico, Pennsylvania and Colorado. All of these legal cases are supported by Our Children’s Trust, a nonprofit organization that seeks the legal right of our youth to a healthy atmosphere and stable climate in the future.

**Democracy Awakening** is a coalition of more than 100 groups representing a diverse array of issues and demanding “a Congress that stands up for democracy rather than stands in its way.” Lead organizations include the American Postal Workers Union, Common Cause, Communications Workers of America, Democracy Initiative, Every Voice Center, Food & Water Watch, Franciscan Action Network, Greenpeace, NAACP, People For the American Way, Public Citizen, Peace Action, Student Debt Crisis, ←350, CodePink, World Beyond War (a full list of organizations can be found at [democracyawakening.org](http://democracyawakening.org)). They mobilized in Washington, D.C. “to protect voting rights, get big money out of politics and demand a fair hearing and an up and down vote on President Obama’s Supreme Court nominee.” Between April 16 and 18 participants went to teach-ins, workshops, non-violent direct action trainings, arts events, a rally for Democracy and a day of non-violent direct action at the Capitol.

**Democracy Spring** was an event with four specific legislative demands:

- Passing legislation to overturn the 2010 Citizens United decision,
- Passing an update to the Voting Rights Act to restore provisions of the law struck down by the Supreme Court in 2013,
- Passing the Voter Empowerment Act to make voter registration easier,
- Passing the Fair Elections Now Act to create a public financing system for Senate candidates.

Participants began a 140-mile walk from Philadelphia to the U.S. Capitol to “demand Congress take immediate action to end the corruption of big money in our politics and ensure free and fair elections in which every American has an equal voice.”

In the course of those joint actions, between April 11 and April 18 close to 1,400 people were arrested at the U.S. Capitol, in what has been called the largest mass civil disobedience since the Vietnam War era. “The Progressive” published a priceless photo of a young woman dressed as the Statue of Liberty being handcuffed and lead away by the police! Among those taken into custody were approximately 60 organization and movement leaders, including NAACP president and CEO Cornell William Brooks, Public Citizen president Robert Weissman, Greenpeace executive director Annie Leonard, radio commentator Jim Hightower, and Ben & Jerry’s co-founders Ben Cohen and Jerry Greenfield.

A "Media Matters" analysis of the broadcast evening and weekend TV news coverage revealed that the networks devoted only two segments – a total of 29 seconds of airtime – between April 11 and April 18 to the week-long demonstrations. Indeed we are lucky to have the Internet and the Social Media.

**Escalation Summer in West Roxbury.** West Roxbury residents are determined to stop the construction of a high pressure pipeline carrying fracked gas which will run within a hundred feet of an active blasting quarry, through residential neighborhoods, and past several schools.

Opponents of the pipeline have been meeting, contacting Representatives and Senators, holding

vigils, educating the public, rallying, marching, and canvassing with a petition to stop the pipeline since 2014. The opposition is growing and so is the grassroots support from across the region.

On May 21, there was a rally and march to the construction site organized by the group Mothers Out Front. On May 25 over 100 people gathered for an interfaith worship service at the site of the pipeline and sixteen clergy members from across the Boston area were arrested after they blocked construction work. On June 1, two men in their 20s dressed as Han Solo and Luke Skywalker were arrested after chaining themselves to a steel plate at the site. This is the opening of what the West Roxbury pipeline resisters call their "Escalation Summer." ## In Memoriam:

### Daniel Berrigan

(May 9, 1921 – April 30, 2016)

"If you are going to follow Jesus, you better look good on wood."  
Dan Berrigan

That's exactly what Fr. Dan Berrigan, S.J. did and he was crucified for years by the Jesuits and many citizens of the US; Catholics included. How dare a Catholic priest protest the Vietnam War and end up in jail?

On May 17, 1968, Dan, his brother Phillip and seven others poured homemade napalm on draft records in the parking lot of the Catonsville, Maryland Draft Board. So began this man's life of civil resistance.

"You have to struggle to stay alive and be of use as long as you can."  
Dan Berrigan

That's exactly what Fr. Dan Berrigan, S.J. did. He managed to live, being of use, until he died on April 30th at age 94. He bluntly told us the truth.

"Of course, let us have peace, we cry, 'but at the same time let us have normalcy, let us lose nothing, let our lives stand intact, let us know neither prison nor ill repute nor disruption of ties ...'  
' There is no peace because there are no peacemakers. There are no makers of peace because the making of peace is at least as costly as the making of war - at least as exigent, at least as disruptive, at least as liable to bring disgrace and prison, and death in its wake."

# Connections

From the 1990 trial of the Plowshares 8. (The first Plowshares actions took place in the King of Prussia, PA in 1980.)

"The defendants (*Fr. Daniel Berrigan, Philip Berrigan, Dean Hammer, Fr. Carl Kabat, Elmer Maas, Sr. Anne Montgomery, Molly Rush, and John Schuchardt*) were told today that they would have to serve 23 months in county jail if they are convicted of any more antiwar activity in the next 23 months, a condition that the defendants said they might not be able to fulfill.

After the sentencing, Daniel Berrigan, who is 68 years old, said: "I'm going to watch President Bush [Sr.] very closely. It all depends on him whether I go back in the pokey or not."
